# **Awning Website Privacy Statement**

## Introduction

Awning Mental Health, Inc. ("**Company**" or "we") offers the website located at <u>www.awning.app</u>, including any content, functionality, and services offered on or through www.awning.app (the "Website") to Website visitors or users ("you" or "your"). We respect your privacy. We and are committed to protecting your privacy through our compliance with this Privacy Statement.

This Privacy Statement describes (i) the types of information we may collect from you or that you may provide to us and (ii) our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Privacy Statement applies to information we collect:

- On the Website.
- In email, text, and other electronic messages between you and us and/or the Website.

This Privacy Statement does not apply to information collected by:

- Us offline or through any means other than the Website, including on any other website we or any third party (including our affiliates and subsidiaries) operate; or
- Any third party (including our affiliates and subsidiaries), including through any application or content that may link to or be accessible from or on the Website.

Please read this Privacy Statement carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use the Website. By accessing or using the Website, you agree to the policies and practices described in this Privacy Statement.

We may change this Privacy Statement from time to time (see **Changes to Our Privacy Statement**, below). All changes are effective immediately when we post them on the Website, and will thereafter apply to your access to and use of the Website. Your continued use of the Website following the posting of revised Privacy Statement means that you accept and agree to the changes. We suggest and expect you from time-to-time to check the Website's Privacy Statement webpage so you are aware of any changes to this Privacy Statement.

#### Children Under the Age of 13

We do not intend children under 13 years of age to use the Website. No one under age 13 may provide any information to or on the Website. We do not knowingly collect personal information from children under 13. If you are under 13, do not use the Website or provide any

information on the Website or on or through any of its features. If we learn we have collected or received personal information from a child under 13 without verification of parental consent, we will delete that information. # Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including information:

- By which you may be personally identified, such as name and e-mail address if you email us, your IP address, or any other identifier you provide by which you may be contacted online or offline (collectively, "**personal information**");
- That is about you, but individually does not identify you; and/or
- About your internet connection, the equipment you use to access our Website, and your Website usage details.

We collect this information:

- Directly from you when you provide it to us; and
- Automatically as you navigate through the Website. Information we collect automatically may include your Website usage details, IP addresses, internet connection, and the equipment you use to access our Website.

#### Information You Provide to Us.

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. We may also ask you for information when you report a problem with our Website.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Your use of Awning Services (as defined in the Awning App Terms of Service).

#### Information We Collect Through Automatic Data Collection Technologies.

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

• Details of your visit(s) to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.

 Information about your computer and internet connection, including your IP address, operating system, browser type, and information collected through cookies, web beacons, and other tracking technologies.

The information we collect automatically helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our Website according to your individual interests.
- Speed up your searches.
- Recognize you when you return to our Website.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file we may place on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system may issue one or more cookies when you direct your browser to our Website.
- Flash Cookies. Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your privacy and security settings for Flash cookies, see Choices About How We Use and Disclose Your Information.
- Web Beacons. Pages of our Website and our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit us, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain Website content and verifying system and server integrity).

#### Third-Party Use of Cookies and Other Tracking Technologies

Some content or applications on the Website may be served by third-parties and application providers. These third parties may use cookies alone or in conjunction with web beacons or other tracking technologies to collect information about you when you use the Website. The information they collect may be associated with your personal information or they may collect information, including personal information, about your online activities over time and across different websites and other online services.

## How We Use Your Information

We use information that we collect about you or that you provide to us, including any personal information:

- To present our Website and its contents to you.
- To provide you with information, products, or services that you request from us.
- To fulfill any other purpose for which you provide the information.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- To notify you about changes to our Website or any products or services we offer or provide though it.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.

#### **Disclosure of Your Information**

We may disclose personal information that we collect or that you provide as follows:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information we hold about our Website users is among the assets transferred.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your personal information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our Terms of Use, and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others.
